

Dear User,

The data supplied in the registration form will be processed, managed and stored by Congress Srl for purposes related to the organization of the WCOA 2014.

Your personal data will be collected and processed in order to complete registration to the World Congress, to manage participation to WCOA sessions and side events, and for statistical purposes.

Data may be communicated to various sub contracting companies that are in charged of specific areas of the organization and to main sponsors.

The process of data will be conducted either with electronic and digital means as well as on paper and by adopting all suitable means and technologies to ensure security and confidentiality as required by law.

In case of refusal to provide data as requested in the form, the registration process will not be completed.

The controller of the data supplied by users is Congress Srl, a limited liability Italian company with head offices in Roma, Piazza della Repubblica 59 – 00185, Tax number 06881651001e-mail congress@pec.commercialisti.it.

Participants' personal data will be accessible and treated by Congress Srl team charged with the WCOA organization and may be accessed, limited to the specific service provided, by employees of other sub contracted companies, charged with registration, digital services, logistical and other Congress-related services.

Both the Consiglio nazionale dei dottori commercialisti ed esperti contabili (Cndcec) and the International Federation of Accountants (Ifac) will have access to participants' data, for statistical and monitoring purposes.

Data Owner's Rights

Under Italy's Personal Data Protection Code, every Data owner has various rights in connection with the processing of their personal data (Section 7, D.lgs 196/03):

1. The right to obtain general information on processing operations performed in our country by accessing, free of charge, the online Register of Processing Operations kept by the Italian DPA;
2. The right to access their own personal data directly at the entity holding such data (the Data Controller), i.e. the right to obtain confirmation that such data exists and communication of the data as well as to know the source of the data and what criteria and purposes apply to its processing. In the latter case the Data Controller may charge a fee ("handling fee") if it is found that no data relating to the data owner is held;
3. The right to obtain erasure or blocking of any data that is processed in breach of the law, for instance because no consent was asked for. This right may also be exercised if there is no valid reason any longer for retaining data that had been collected lawfully;
4. The right to have inaccurate and/or incomplete data updated, rectified or supplemented;
5. In the cases mentioned under 3. and 4. above, the right to obtain confirmation from the Data Controller that the above operations have been

also made known to the entities the data had been communicated to beforehand, unless this proves impossible or requires a disproportionate effort compared to the right to be protected;

6. The right to object to the processing of one's own data on legitimate grounds;

7. The right to object, in any and all cases, to the processing of one's own data for commercial information purposes and/or for sending advertising or direct selling materials and/or for market research purposes.

You also have the right, at any time, to oppose the treatment of data and receipt of communications via e-mail, with the consequent request to cancel the data. Holder of the data is Congress Srl with its operational headquarters in Rome, Piazza Della Repubblica, 59 .
